The purpose of this present correspondence is to introduce our organization and to open a diplomatic correspondence channel between SWISSINDO WORLD TRUST INTERNATIONAL ORBIT-NEO THE UNITED KINGDOM OF GOD SKY EARTH and THE LEADERS OF THE WORLD. As we all share the same vision and goal for our humanity which is total freedom, equality, prosperity and peace for all nations and peoples of our planet.

In 1963, The Green Hilton Memorial Agreement was signed by Indonesian President Soekarno, President John F. Kennedy and William Vouker representing Switzerland in Geneva, Switzerland.
